The Resolution is requesting that the City of Los Angeles include in its 2019-2020 Federal Legislative Program SPONSORSHIP and/or SUPPORT of legislation that would amend the federal Internal

Revenue Code to include a tax deduction, tax exemption or tax credit for any housing tenant receiving relocation assistance as a result of a lawful eviction undertaken for any reason.

Motion is requesting the Office of the City Attorney with the assistance of the Office of Finance, to prepare and ordinance to exempt motels leasing their units for the purpose of housing homeless individuals in partnership with government and homeless service providers from being required to collect and remit Transit Occupancy Tax.
